HAMLETS

The monthly Parish Council meeting was held on Wednesday 15th September in the Community Centre. Present were, Cllrs. J Hobbs (Chair), K Boundy, M Hodgson, J Payne, J Phipps, R Savage, N Steer and G Worden, 7 members of the public and Mrs S Joyner (Clerk). Apologies were accepted from Cllr. S Tilbey and Mr K Jones.

Cllr. Hobbs confirmed that the toilets outside the Community Centre had been re-opened after the cleaner had carried out a deep clean. The repairs to the slide and the tower in the playpark have been completed. No quotes were received for the work to carry out repairs to the playpark fence so this will be advertised again and put on the October agenda for discussion. Further details inside Hamlets. The external audit has been completed by PKF Littlejohn. There were no issues and a Notice of Completion of Audit has been granted.

In the Public Participation part of the meeting Mrs S Teare spoke about the system Cornwall Council operated regarding the issue of site notices for planning applications and that not all nearby residents would be aware of proposed plans. It was agreed this was a matter for the ward councillor to look into. Miss A Smeeth spoke about an active planning application and the need for local housing.

There had been several consultations that had been received for discussion and response. These will be discussed at the October meeting and responses formulated. The Parish Clerk/RFO vacancy has been readvertised with interviews taking place at the end of September.

There were two pieces of correspondence received concerning traffic issues in the Parish. One was concerning speeding traffic along the road past the community centre, the other was concerning traffic movements of heavy lorries, road safety aspects and quarrying. All of these concerns have been referred to Cornwall Council.

There were 3 planning applications discussed: PA21/06884; Replacement conservatory, 2 Jacques Cottages, Shop. Comments submitted to C C: Morwenstow Parish Council does not object to this application. PA21/07058; Outline application with some matters reserved for a single dwelling, Stone Park, Woodford. Comments submitted to C C: Morwenstow Parish Council would like to support this application but is mindful of the legislation that is already in place covering this piece of land. PA21/07903; Conversion of existing block stable building to single storey ancillary accommodation with proposed link to existing dwelling and increase to residential curtilage, Middlefields, Woodford. Comments submitted to C C: Morwenstow Parish Council is of the opinion that this proposal bears no resemblance to the advice given to application PA20/02238/PREAPP. It is considered that the link is too large and that there is not enough use of traditionel building materials. The council also feels that this proposed building would have a detrimental affect on the barn at the east elevation. Morwenstow Parish Council objects to this application.

The next meeting of the Parish Council will be on Wednesday 20th October at 7.30pm in the Community Centre
