**Proposal:** Non-material amendment (1) to vary the fencing material from the approved metal chain link mesh security fencing to deer stock fencing consisting of wooden posts and wire in respect of decision notice PA10/08695 - installation of a solar energy facility on land near Eastcott Cross, near Bude.
