

Morwenstow Parish Council

Minutes of the Parish Council Meeting held on
Wednesday 15th June 2016 at 7.30pm in the Community Centre

- 1. Attendance** Meeting Chaired by Cllr. Hobbs. Also present Cllrs. Boundy, Chapman, Colwill, Francis, Rogers and the clerk.
- 2. Apologies** received from Cllrs. Braund, Savage, Tilbey and Wickett.
- 3. Minutes** of the meeting held on 18th May were agreed and signed as an accurate record of the meeting.
- 4. Matters arising from the minutes** The APM on 25th May had been a really good meeting. Thanks to all involved. The Queen's birthday celebrations and carnival went well and all who came enjoyed the tea and the film show. Again thanks to all involved, especially Cllr. Rogers. Three Councillors had now had DBS checks completed, just Cllr. Tilbey to be checked. Cycling training -affiliation details and risk assessment had been seen and Cllr. Hobbs advised that details to be approved by Devon Council before commencement of classes in car park and practise pitch. Keep an eye on the mole hills. As previously agreed Cllr. Colwill to get quotes for repair of wobbleboard and a piece of new equipment.
- 5. Dispensations/Disclosure of Interest for items on the agenda** Cllr. Rogers expressed an interest in item 8.
- 6. Application for funding for M C C /M C C link to our website** All agreed that Community Centre link could be added to website. Application for funding for wi-fi at Community Centre to be submitted by 1st July.
- 7. Parish maintenance - quotes for signs, fences, cutting and car park work, Woolley pond.** Still waiting quotes for fence and car park work. Quote for fence will include using existing wire but new timber around practise pitch and East and North sides of playing field. Quote for cutting of inland paths had been received and all resolved to accept. Agreed to purchase sign to go above Parish Council noticeboard. Cost approximately £50 for screwable wood sign with smallest font in black. All agreed to purchase of 2 slippery surface signs for CC public toilets. Cost Approximately £10 each. Cllrs. Boundy and Colwill reported that Woolley pond is now just a piece of swampy ground and not considered dangerous. Confirmed as previously that fence served no useful purpose. Residents to keep tree trimmed.
- 8. Aunt Amy's Garden** Cllr. Rogers took no part in this item. Letter received from WI advising they were no longer in a position to upkeep the garden. Piece to be put in Hamlets asking for volunteers to help. See what response is received and put on agenda for next month.
- 9. Duckpool toilets advertising board** Any board erected would need planning permission as well as agreement from National Trust. Agreed 1 notice could be put on toilet door advertising church services but to monitor in case any other notices were put up.
- 10. Freeman of the Parish award** To be discussed at special meeting next month.
