The Parish Council are not invited to submit consultee comments on this application as it is Prior Approval, however, the application was discussed and the following comments were sent to the Planning Officer: In June 2009 Planning Application E1/2009/00900 for a proposed straw bedded livestock building with fodder storage area was submitted by Mr Greaves. This application was approved on 18th August 2009. According to the documents submitted with PA17/06035 this building was never used for the purpose it was intended but was used as a warehouse for the purpose of running a distribution business. The original approval had been granted for an agricultural building and, as far as the Parish Council is aware, no change of use was sought or granted. Had the Parish Council been aware that the building was being used for purposes other than that applied for, the matter would have been referred to the Enforcement Team at Cornwall Council. The Parish Council feels strongly that this matter should be addressed before any consideration is given to this new application for change of use to a residential dwelling. Cllrs. Phipps and Richards took no part in the discussion.
