**14.17/07** Members Reports: A leak in the taps at the public toilets outside the Community Centre had been reported that day. The toilets are in constant use and the Clerk approved urgent repairs. Cllr. Francis to get it attended to immediately as there was an

outdoor function at the weekend. Cllr. Boundy reported that some of the doors on the Parish noticeboards were hard to close. Cllr. Hobbs suggested he use a silicone based lubricant on them. Cllr. Boundy reported that a caravan was parked at Woolley Cross. He was advised to report to Cormac. Cllr. Colwill reported that Outdoor Playpeople had been and replaced the faulty parts on the springer. Cllr. Colwill mentioned that some people felt the wi-fi box could have been placed higher to get a better reception. No action at present. Cllr. Hobbs reminded all about the Parish walk the following day and noted that it had been put incorrectly in Hamlets as a Parish Council walk. This was not the case, it was a Parish walk, and had not been organised by the Parish Council.
