Proposal: Installation of a deer stock fence around the perimeter of the solar farm following the original layout as approved

under the original application reference PA10/08695 **Location:** Land South of Woolley Barrows Morwenstow

Applicant: Push Energy Ltd

Morwenstow Parish Council objects to this application. When the solar farm was first proposed local residents were informed that there would be screening, that there would be a Community benefit fund, and that there would be no reflection or heat haze from the panels. This is not the case as local residents do suffer from reflection and heat haze from the panels, furthermore, there is no fund set up to benefit the community and no noticeable screening. The Parish Council would suggest that no further applications are approved until previous conditions relating to screening have been met.
